1- Tourism eVisa

Visa processing:

Upon submitting a successful eVisa application, the visa issuance time ranges between 30 minutes, and up to 48 hours. The eVisa will be issued and sent to the requester's email.

Visa cost, validity and stay duration:

The estimated cost of the e-visa start from SAR 480 equivalent to USA 128. The visa is valid for 1 year. The stay duration is 90 days. This visa allows for multiple entries. Find more details at [eVisa](#)

2- Transit by Sea eVisa (For transit guests only *)

All Countries.

Visa processing:

Upon submitting a successful Transit by Sea visa application, at least 12 hours before arrival to Saudi Arabia, the visa will be processed and to sent to the requester's email. (The ship must share passenger a final manifest with Cruise Saudi, 48 hours in advance of the arrival time, for the visas to be approved)

Visa cost, validity and stay duration:

The cost of the Transit visa by sea start from USA 21.5 (USD 11 for registration, USD 10.5 for Medical registration, plus compulsory health insurance fees). Visa validity is 90 days. This visa allows only for a single entry. The stay duration is 96 hrs. from the time of entering Saudi Arabia *.

This visa is not suitable for guests wishing to disembark in Saudi Arabia. Disembarking guests must apply for the Tourism eVisa if they wish to disembark in Saudi Arabia. This visa is strictly for passengers who are in transit. Additional instruction is attached in separate file.

Process Requirements On arrival

Tourism & Transit Visa

1. Passengers going ashore must print the Visas, and have it ready along with the passport and ship card. (exception made at point number 3)*.
2. Passenger without approved and printed eVisas with ship card **are not allowed to leave the ship or go ashore.**
3. * Passengers wishing to apply for Tourist visa on arrival must pay the cost of the tourist visa (USD 128) via credit card, onboard the ship. then take the payment slip along with the passport and ship card to go ashore and continue process at the terminal.
4. Transit visa application cut off time will take place today at 19:00 on the day before ship arrival, after this time transit visa applications will not be processed.
5. Including Shorex tours, all passengers going ashore must print the Visas, and have it ready along with the passport and ship card.
6. Passengers going ashore in Yanbu must apply for the visa, obtain the entry and exit stamp in Jeddah. All guests must show the passport and open the passport's page showing the exit stamp from Jeddah along with the ship card.
